Centre Pointe Stallion Service Contract

This contract is made by and between Darlene York (Country Lane Farm) and _____
for the breeding of the mare _____ to the stallion Centre Pointe for the current
breeding season and subject to the following terms and conditions:

1. Stallion fee is \$1200 CDN. All fees must be paid prior to shipment of semen and are subject to G.S.T. for Canadian residents. Country Lane agrees to provide viable semen.
2. Each party agrees that semen is provided for the mare described in the contract only. Confirmation of insemination and conception of mare must be received by Stallion owner before a signed breeding certificate will be released to mare owner for foal's registration. Embryo transplants are prohibited without prior written permission for stallion owner.
3. All fees incurred by Mare Owner Lessee for the breeding of the mare are the responsibility of the Mare Owner / Lessee, including semen related expenses, shipping expenses, as well as mare or foal expenses incurred. The mare owner must provide a credit card or Fedex number for the cost of the shipment or \$300 per shipment plus 5% for Canadian Residents.
4. Breeding Season shall extend from March 1st - until September 1. Please contact Channay Lloyd for Centre Pointe's show schedule as he will not be available for collections during the horse shows.
5. **All semen orders must be received before 11:00 am Pacific Standard time the 24 hours prior to breeding your mare. Late requests will be honored only if collection is possible.**
6. Mare Owner Lessee shall not be entitled to a refund for fees paid, however the mare shall have the right to return to the stallion for the following breeding season unless mare becomes unbreedable and such condition is verified by a certificate of a veterinarian. At that time the Mare Owner Lessee may substitute another approved mare, a new contract must be signed for the substitute mare.
7. Mare owner warrants that mare is in sound breeding condition. Mare owner agrees that mare will be bred by Veterinarian with considerable experience in artificial insemination and has access to an ultrasound machine.
8. This contract shall be null and void and Mare Owner Lessee shall be entitled to one of the Farm's other stallions or frozen semen if the stallion should die or become unfit to breed.
9. Live foal Guarantee: A live foal is defined as a foal that stands and attempts to nurse. The live foal guarantee is valid until the end of the following year's breeding season.
10. Should the mare fail to be in foal or there is no live foal as a result of the first breeding the stallion owner agrees to ship semen for a repeat service upon the receipt of \$300 CDN for the collection fee plus 5% GST for Canadian residents.
11. The laws of the Province of British Columbia, Canada shall govern the terms of this agreement.
